The successful candidate will play a crucial role in planning, implementing, and evaluating programs aimed at improving the sustainability of our food systems and reducing greenhouse gas emissions.

## **Primary Responsibilities:**

- 1. Assist with the design and set up of a new greenhouse operation.
- 2. Ensure soil pH levels are suitable for food production.
- 3. Collect and plant local/heritage seeds in the greenhouse and community gardens.
- 4. Design horticulture plans and oversee seed planting.
- 5. Care for and maintain two existing community gardens.
- 6. Maintain watering schedules for greenhouse and gardens.
- 7. Monitor water usage and recommend efficiency improvements.
- 8. Calculate greenhouse gas emissions produced by the operation of the new greenhouse.
- 9. Identify opportunities to reduce emissions through improved practices and tools/systems.
- 10. Conduct educational tours for community members and school groups.
- 11. Supervise volunteers as needed for daily tasks.
- 12. Prepare summary reports with findings and recommendations after the harvest season.
- 13. Educate the public on home food production.

- 14. Record and maintain environmental parameters for indoor hydroponic plants.
- 15. Manage pest control measures for food production.

- Must be between the ages of 18 and 30 years old.
- Must be a recent post-secondary graduate in related field of study.
- Passion for nature, gardening, and sustainable practices.
- Knowledge of greenhouse operations, horticulture, and food production or willingness to learn.
- Familiarity with sustainability principles and environmental conservation.
- Strong communication and organizational skills.
- Ability to multitask, think creatively, and problem-solve.
- Experience working with diverse groups of people.
- Self-motivated, exceptional time management skills, and the ability to work independently.
- Proven ability to plan and execute projects from start to finish.
